**(13 COUNTS)**

Breach of section 19(1)(a) and (3)(a) of the Children's Act Coupled with Section 8 (1) (a) of the Children's Court Act 2020

**BEFORE THE CHILDREN'S COURT (CRIMINAL DIVISION)**

**COUNT I**

That on a day between the 9<sup>th</sup> of May 2022 and 20<sup>th</sup> of June 2022, at School for the Welfare of the Deaf, Pope Henessy Road, Beau Bassin, in the district of Plaines Wilhems, one **IBRAHIM ABDOOL JEELANI SOREFAN**, 25 years (NIC S1111974403525), speech and language pathologist, residing at Toutcourt Street, Highland, Phoenix, did wilfully and unlawfully sexually abuse a child under the age of 16, to wit: **minor Ryan Gabriel Rasé, born on 23/02/2008, a child with a physical handicap.**

That on a day between the 9<sup>th</sup> of May 2022 and 20<sup>th</sup> of June 2022, at the place aforesaid, in the said district, the said **IBRAHIM ABDOOL JEELANI SOREFAN**, did wilfully and unlawfully sexually abuse a child under the age of 16, to wit: **minor Craig Mitch Nathaniel Lebon, born on 27/11/2009, a child with a physical handicap.**

That on a day between the 9<sup>th</sup> of May 2022 and 20<sup>th</sup> of June 2022, at the place aforesaid, in the said district, the said **IBRAHIM ABDOOL JEELANI SOREFAN**, did wilfully and unlawfully sexually abuse a child under the age of 16, to wit: **minor Alexander Edward Anseline, born on 05/04/2013, a child with a physical handicap.**

**COUNT IV**

That on a day between the 9<sup>th</sup> of May 2022 and 20<sup>th</sup> of June 2022, on a second occasion, at the place aforesaid, in the said district, the said **IBRAHIM ABDOOL JEELANI SOREFAN**, did wilfully and unlawfully sexually abuse a child under the age of 16, to wit: **minor Alexander Edward Anseline, born on 05/04/2013, a child with a physical handicap.**

That on a day between the 9<sup>th</sup> of May 2022 and 20<sup>th</sup> of June 2022, at the place aforesaid, in the said district, the said **IBRAHIM ABDOOL JEELANI SOREFAN**, did wilfully and unlawfully sexually abuse a child under the age of 16, to wit: **minor Lorgeshwaree Lorshini Aroomoogon, born on 27/02/2012, a child with a physical handicap.**

**COUNT XIII**

That on a day between the 9<sup>th</sup> of May 2022 and 20<sup>th</sup> of June 2022, on a second occasion, at place aforesaid, in the said district, the said **IBRAHIM ABDOOL JEELANI SOREFAN**, did wilfully and unlawfully sexually abuse a child under the age of 16, to wit: **minor Lorgeshwaree Lorshini Aroomoogon, born on 27/02/2012, a child with a physical handicap.**
